## POLICY/REQUIREMENTS

All vendors will need to provide a certificate of Insurance carrying \$2,000,000.00 liability and naming the City of St. Catharines, the Downtown St. Catharines Busker Fest, and Kobblestone Productions Inc, as additionally insured (We can suggest an insurance provider if you need one).

**Cancellations** are to be received in writing 30 days prior to the event. A cancellation fee of \$75.00 will apply.

All vendors must provide their own set-up such as: tent, tables and chairs (**weights to hold tents down are a must**).

Please list all items to be sold – add an extra page if required.

Lighting is highly recommended – Solar lighting is a good alternative when power is not available.

Overnight Security is provided however we cannot be responsible for lost or stolen items.

Applications without payment or waiver signed are not considered complete and priority will be given to complete applications.

No cheques will be accepted – Etransfer or Bank drafts only - Fees must be paid in full to participate.
